5) 2. In this regard, it is stated that security to an individual is provided on the basis of comprehensive threat assessment made by the Security Agencies. The details of security provided to an individual cannot be disclosed, as these are exempted under Sections 8(1)(g) and 24(1) of the RTI Act-2005. Regarding expenditure incurred in providing security to an individual, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.

3. However, a copy of your RTI application is being forwarded to Cabinet Secretariat for providing information, if any, they may have.
