

With regard to point (2) of your application, it may be stated that SPG security cover is provided to Prime Minister/former Prime Minister and members of their immediate family in terms of the SPG Act, 1988. Further details may be available with Cabinet Secretariat, for which a copy of your RTI application is being forwarded to
- 4. With regard to point (3) of your application, it may be stated that details in this regard are exempt under Sections 24(1) and 8(1)(g) of the RTI Act-2005.
- 5. With regard to point No.(4) of your application, it may be stated that responsibility for providing security to an individual, including Member of Parliament, is primarily that of the State Government concerned, in whose jurisdiction such individual ordinarily resident or happens to be. Due to involvement of multiple agencies, including State Government agencies, it is difficult to estimate the expenditure on providing security. In any case, such details are not maintained in this Ministry.

- 6. With reference to point Nos. (5) and (19), it is stated that security to an individual is provided on the basis of comprehensive threat assessment carried out by the security agencies. On the basis of gravity of threat, categorized security is provided to an individual at government cost. Due to involvement of multiple agencies, including State government agencies, it is difficult to estimate the expenditure on providing security and such details are not maintained in this Ministry.
