- 2. In this regard, it is stated that the Security to Prime Minister of India. Shri Rahul Gandhi, MP and Smt. Sonia Gandhi, MP is being provided by the SPG. The details may be available with them. The information in respect of SPG is exempted under Section 24(1) of the RTI Act-2005. However, a copy of RTI application is being forwarded to SPG for taking appropriate action under the RTI Act-2005.
- Regarding expenditure on providing security to Cabinet Ministers, it is stated that security is provided on the basis of comprehensive assessment of threat by security agencies and the concerned State Governments/State Police are responsible for providing security whenever these protectees are in their jurisdiction. Due to the involvement of multiple agencies, including State Government agencies, it is difficult to calculate the expenditure incurred by the concerned State Governments/State Police and the other security agencies. There is no consolidated account of such expenditure under any one head. No such information on expenditure incurred on providing security to individuals is either maintained or available in this unit.
