Sir,

Please refer to your RTI application dated 29.08.2013 received in this unit on transfer on 03.10.2013 for furnishing information in respect of point No.(8) of the application.

2. In this regard, it is stated that security to an individual including MPs is provided on the basis of comprehensive threat assessment carried out by the Security Agencies. Further details in this regard are exempted under Sections 8(1)(g) and 24(1) of the RTI Act-2005.


3. It is further stated that provision of security to an individual is primarily the responsibility of the State Government concerned, in whose jurisdiction such individual ordinarily resides or happens to be. Due to involvement of multiple agencies, including State Government agencies in providing security, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.

However, in 2010, there were 211 number of threat based categorized protectees in the Central list and there are 218 number of categorized protectees in the Central list as on date.


