In this regard, it is stated that the matter of exemption from pre-embarkation security check at Indian airport comes under the jurisdiction of the Bureau of Civil Aviation Security, Ministry of Civil Aviation. However, the proposal for exemption from pre-embarkation security checks in case of Shri Robert Vadra, when travelling with SPG protectees, was considered in this Ministry in consultation with security agencies and was recommended to Ministry of Civil Aviation on security considerations. Further details in this regard are exempted under Section 24(1) of the RTI Act-2005.
