

- In this regard, it is stated that the matter referred by you is being heard by Hon'ble Supreme Court of India in Special Leave Petition (Civil) No. 25237/2010-Abhay Singh vs State of UP and Ors. The details/history of the case are available in the public domain on the website of Supreme Court of India(www.supremecourtofindia.nic.in) through which the relevant information can be obtained. The daily orders issued by the Court in this regard are also available on that website. This Ministry is concerned with only the issues pertaining to personal security. In compliance with the Hon'ble Court's order dated 01.05.2013 in the case, Affidavits by MHA on the issue relating to personal security, have been filed on behalf of U.O.I., which was sent to Central Registry for filing in the month of June, 2013 and August 2013. No expenditure has been incurred by this unit towards lawyers' fees so far in connection with this case. However, an expenditure of Rs.1190/- has been incurred by this unit towards notarization of the affidavits filed in connection with this case in the Supreme Court.
- Matters related to use of red lights or beacon is not related to this unit, the same may be related to Ministry of Road Transport and Highways. Accordingly, a copy of your application is being forwarded to Ministry of Road Transport and Highways for providing information directly to you.
