2. In this regard, it is stated that points (1), (2), (5) and (7) of your application relate to Ministry of Civil Aviation. Accordingly, a copy of your application is being transferred to that Ministry to furnish the desired information directly to you.

As regards points (3) and (4) of your application, it is stated that MHA may on security grounds, on the basis of inputs from Security Agencies, recommend that some individual may be exempted from pre-embarkation security checks. Further details in this regard are exempted under Section 24(1) of the RTI Act-2005.
4. With regard to points (6) and (9) of your application, it is stated that communications containing recommendation for such exemption are based on inputs from security agencies, which are exempted under Section 24(1) of the RTI Act-2005. The information is also exempted under Section 8(1)(j) of the RTI Act-2005, therefore, neither copies of relevant documents nor permission to inspect any file relating to the same, can be given.
5. As regards point (8) of your application, the Administration Division of this Ministry, may have some information. Accordingly, a copy of your application is being transferred to that Division to furnish requisite information directly to you.
