Sir,

Please refer to your online RTI application Registration No.MHOME/R/2013/61416 dated 15.10.2013 received in this Unit on transfer on 18.10.2013.

2. In this regard, it is stated that the matter of exemption from pre-embarkation security check at Indian airport comes under the jurisdiction of Bureau of Civil Aviation Security, Ministry of Civil Aviation. In view of this, point Nos. (1) to (3) and (5) to (7) of your application are not related to this unit. The same are related to BCAS. Accordingly, a copy of your RTI application is being transferred to Bureau of Civil Aviation Security, MCA for providing information directly to you under the RTI Act-2005. However, it may be stated that the proposal for exemption from pre-embarkation security check in case of Shri Robert Vadra, when travelling with SPG protectees, was considered in this Ministry in consultation with Security agencies and was recommended to Ministry of Civil Aviation on security considerations. Further details in this regard are exempted under Section 24(1) of the RTI Act-2005.

3. Point No.(4) of your application is related to Cabinet Secretariat. Accordingly, a copy of your RTI application is being transferred to Cabinet Secretariat under Section 6(3) of the RTI Act-2005, for providing information directly to you.
