
Sir,

2. This unit deals with the provision of security cover to individuals which is provided based on comprehensive threat assessment for such an individual. In this context it may be stated that the terms 'VVIP' and 'VIP' are used in a general sense in relation to high dignitaries. There is no formal official nomenclature defining these terms and therefore the question of conferring 'VVIP' or 'VIP' status on an individual does not arise nor does such 'status' carry provision of any benefits.
