Sir,

Please refer to your online RTI application Registration No.MHOME/R/2013/61595 dated 30.10.2013 received in this Unit on transfer on 05.11.2013.

2. Point Nos. (2) and (3) of your application are related to this unit. With regard to Point No.(2) of your application, it is stated that the responsibility for providing security to an individual rests primarily with the State Government concerned, under whose jurisdiction such individual is ordinarily resident. Even where security is provided by the central government, the same is done on the basis of threat assessment carried out by the central security agencies. It is not possible to arrive at the exact number of categorized protectees as it varies from time to time based on the threat assessment made by the Central Security Agencies. However, there are 59 numbers of threat based Protectees in Z category in the Central list as on date. In addition State Governments have their separate list of protectees including that of Z categories protectees.

3. With regard to Point No.(3) of your application, it is stated that security to an individual is recommended on the basis of threat assessment carried out by the Security Agencies. It is not provided merely on the basis of an individual being an RTI Activist etc. No separate information is maintained regarding recommendation/provision of security to any RTI Activist. Further, since provision of security to an individual is primarily the responsibility of the State Government concerned, hence, the information may be obtained directly from the State Government concerned under the RTI Act-2005.

4. However, a copy of the above application is being forwarded to DOP&T, the nodal Ministry for RTI matters, for providing information, if any, they may have, on the subject, directly to you.

5. Further, Point Nos.(1), (4) and (5) of your application are not related to this unit. Point No.(1) is related to Administration Division, Point No.(4) is related to Police-I and Point No.(5) is related to CS Division of MHA. Accordingly, a copy of your application is being forwarded to them for providing requisite information available with them, if any, directly to you.

6. An appeal if any, against this reply may be made within 30 days to Shri Lokesh Jha, Joint Secretary (PP) & Appellate Authority, Ministry of Home Affairs, 3rd Floor, NDCC-II Building, Jai Singh Road, New Delhi-110001.
