Please refer to your online RTI application Registration No.MHOME/R/2013/61700 dated 09.11.2013.

2. The point-wise reply in respect of points raised by you is as under:

- (1) Point No.(1): The provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Security to an individual is provided on the basis of comprehensive threat assessment carried out by the Security Agencies. Ministry of Home Affairs is concerned with the security arrangements for categorized protectees in the Central list.
- (2) Point No.(2): This point does not relate to VIP Security Unit. Accordingly, a copy of your RTI application is being forwarded to CS Division of MHA for providing information, if any, they may have on the subject.
- (3) Point No.(3): There are four types of categorized security cover i.e. X, Y, Z and Z+. Categorized security is provided on the basis of threat assessed by the Security Agencies. Your query about security clearance available at public places is not clear; hence no reply can be given.
- (4) Point No.(4): The details in this regard are exempted under Section 8(1)(g) and 24(1) of the RTI Act-2005 and therefore cannot be disclosed.
- (5) Point No.(5) and (6): These points are related to Cabinet Secretariat. Accordingly, a copy of your application is being forwarded to Cabinet Secretariat for providing information available with them, if any, directly to you.
