- 2. In this regard, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. The security to an individual is provided on the basis of threat assessment carried out by the security agencies. Security to the Prime Minister is provided in terms of provision of SPG Act. Certain high level dignitaries such as Ministers etc. are provided security taking into account threat attached to the position held by them. Further details in this regard are exempted under Sections 8(1)(g) and 24(1) of the RTI Act-2005. A copy of your RTI application is however being transferred under Section 6(3) of the RTI Act-2005 to Cabinet Secretariat for providing information available with them, if any, to you directly.
- 3. As regards expenditure incurred on provision of security, it is stated that due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office. However, a copy of your RTI application is being forwarded to Delhi Police for providing requisite information to you directly.
- 4. An appeal if any, against this reply may be made within 30 days to Shri Lokesh Jha, Joint Secretary (PP & VS) & Appellate Authority, Ministry of Home Affairs, 3rd Floor, NDCC-II Building, Jai Singh Road, New Delhi-110001.
