Please refer to your online RTI application Registration No.MHOME/R/2013/62005 dated 14.12.2013 received in this unit on transfer on 17.12.2013.

2. In this regard, it is stated that security to an individual is provided on the basis of threat assessment carried out by the Security Agencies. The details in this regard are exempted under Sections 8(1)(g) and 24(1) of the RTI Act-2005. Regarding expenditure incurred on providing security, it is stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.

3. The subject matter of death of key scientists and status of enquiry thereon is not the subject matter of this unit. This Unit does not maintain any such consolidated list. The matter may be related to State Government concerned or the Departments concerned. Since there are many departments where scientists are working and you have not mentioned any particular field, hence you may contact CPIO of concerned department or PIO of State Government concerned for further information directly under the RTI Act-2005. However, a copy of your RTI application is being forwarded to CPIOs of Ministry of Earth Science, Ministry of Defence, Ministry of Environment & Forests, Deptt. of Science & Technology, Ministry of Agriculture, Deptt. of Space, Deptt. of Atomic Energy and Indian Council of Agricultural Research (ICAR).
