In this regard, it is stated that the responsibility for providing security to an individual rests primarily with the State Government concerned in whose jurisdiction such individual is ordinarily resident or happens to be. Further, security to an individual is provided on the basis of threat assessment carried out by the Security Agencies. Based on such assessment, security of various categories may be provided viz. X, Y, Z and Z+.
