Please refer to your RTI application dated 14.11.2013 received in this unit on transfer on 26.12.2013.

- 2. In this regard, it is stated that categorized security cover to an individual is provided at government cost on the basis of threat assessment carried out by the Security Agencies. It is further stated that provision of security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Further details in respect of individual protectees are exempt under Section 8(1)(g) and 24(1) of the RTI Act-2005. Review of security is done from time to time in consultation with the Security Agencies, on the basis of which security is withdrawn/downgraded/upgraded/continued.
- 3. As regards expenditure on security, it may be stated that due to involvement of multiple agencies, including State Government agencies, in providing security, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.
- 4. An appeal if any, against this reply may be made within 30 days to Shri Lokesh Jha, Joint Secretary (PP & VS) & Appellate Authority, Ministry of Home Affairs, 3<sup>rd</sup> Floor, NDCC-II Building, Jai Singh Road, New Delhi-110001.
