Point No. 01 to 04:- The questions pertain to the Delhi Desk of this Ministry. Hence, a copy of the RTI application is being transferred under section 6(3) of the RTI Act, 2005 to US (Delhi), Ministry of Home Affairs, New Delhi for taking necessary action at their end.

Point No. 05 & 06:- The applicant is informed that DANICS officers are not appointed on ad-hoc basis in the entry grade. Further in the Entry Grade of DANICS, 50% vacancies are for the promotion quota from the feeder grade services of UTs. There is no separate quota for Delhi. To have a clear idea, the applicant may refer to the DANICS Rules, 2003 which may be accessed from the website of MHA i.e.(www.mha.nic.in).




