With due submission, I am to state that I had opted to voluntary retirement from Government Service w.e.f. 10.07.2013 vide my application dated 12.02.2013 to this effect filed in Trade & tax Deptt, GNCT of Delhi where I was working as Joint Commissioner(VAT), since my family circumstances at that time were compelled me not to continue in Government service. However, as the family circumstances eased doubt positively, thereafter I withdrew notice to voluntary retirement intimation to this effect was furnished to my department on 29.05.2013. Subsequently a letter intimating the same i.e. withdrawal of notice of voluntary retirement was also sent to your goodself on 30.05.2013.

It is, however, learnt that my information relating to withdrawal of notice of voluntary retirement has not been considered in the ministry and the order accepting my voluntary retirement from services w.e.f. 10.07.2013 have been issued by the Ministry. These developments are against my wished stand retired from Government Service till my actual date of superannuation. This is also against the spirit of fundamental right and enshrined upon every citizen/government servant and under the Constitution of India.
