ORDER

Smt. Renu Mehra has preferred an appeal dated 22.10.2013 stating that she has not been supplied the requisite information to his RTI application dated 24.07.2013 on points (ii) to (iv) and (vi) & (vii).

2. The CPIO vide this Ministry's letter dated 18th September, 2013 has provided the relevant information on all the points of the RTI application dated 22.10.2013 that "the applicant may refer relevant rules available in the website of DoP&T/relevant Dept." for points (ii) to (iv) and "no such data is maintained/readily available in the section" for points (vi) & (vii).

3. The appeal filed by Smt. Renu Mehra has been carefully considered and it is found that the aforesaid reply/decision of the CPIO with reference to her RTI application dated 24-07-2013 are in conformity with the Right to Information Act, 2005. However, the application dated 24.07.2013 is being forwarded to DoP&T and Delhi Police for providing reply on points no (ii) to (iv) and (vi) to (vii) respectively, directly to the applicant under intimation to this ministry.

4. The appeal is accordingly disposed of.

(ii) to (iv) the CPIO has stated that the applicant may refer to relevant rules available in the website of DOP&T/relevant department whereas the copies of the relevant rules were required to be made available to me and in case the required information was not available in your department my application should have been transferred to the concerned department under intimation to me.</p> <p>(vi). The information sought should be available in your department as Mrs. Vimla Mehra IPS (AGMUT 1978) could not have travelled to any foreign country without the approval from the Ministry of Home Affairs.</p> <p>(vii). Similarly IPS officers of 1978 batch of AGMUT cadre cannot visit any foreign country without the approval of Ministry of Home Affairs. The information is not exempted under the rules as all IPS officers are public servants and the public should know where they are travelling and from where the funds for the journeys so undertaken are being arranged.</p> <p>The information on points <u>ii to iv</u>, <u>vi</u> and <u>vii</u> in my application dated 24.7.13 may be provided to me</p>
