S.O. 53(E). Whereas under section 6 of the North-Eastern Areas (Reorganisation) Act, 1971 (31 of 1971), the territories specified therein form the Union territory of Mizoram on and from the "appointed day";

And whereas the 21st day of January, 1972,

has been appointed as the "appointed day" by the
Central Covernment under clause (b) of section 2 of
the said Act;

And whereas under section 77 of the said Act, the provisions of Part II of the said Act shall not be deemed to have effected any change in the territories to which any law in force immediately before the appointed day extends or applies, and the territorial references in any such law to the existing State of Assam shall, until otherwise provided by a competent Legislature or other competent authority, be construed as meaning the territories within that State immediately before the said appointed day;

And whereas the powers exercisable by the State Government under any such law as aforesaid are now exercisable by the Central Government;

Now, therefore, in pursuance of clause (1) of article 239 of the Constitution, and all other powers enabling him in this behalf, the President hereby directs that, subject to his control and until further orders, the Administrator of the Union territory of Mizoram shall, in relation to

the said Union territory, exercise and discharge, with effect from the 21st day of January, 1972, the powers and functions of the State Government under any such law.
