2	Sanctioned posts as on 17.09.2012 at IGP level in different segments of AGMU cadre were as under:- Delhi-20, Chandigarh-1, Puducherry-1, Goa-1, A&NI-1, Mizoram-1+2=3 (decided to operate two posts of IGP at Mizoram for two years vide O.M. dated 17.09.12). Arunachal Pradesh-2+3=5 (decided to operate three posts of IGP at Arunachal Pradesh for two years vide O.M. dated 17.09.12). The incumbency position in each segment is updated, time to time in UTS-I section according to the joining/relieving of the officer on transfer/posting. Hence, incumbency statement as on 17.09.12 is not available in UTS-I section. Applicant may seek information from the CPIO in State Government, where he is serving.
3	The O.M. for operation of post at the level of IGP in Mizoram was issued on 17.09.2012. There is a general shortage of DIGs across the AGMU cadre and therefore, this measure was undertaken as temporary arrangement. As per the 2 nd proviso to Rule 4(2) of the IPS (Cadre) Rules, 1954, MHA is competent to take decision for the temporary operation of these posts for two years, hence Government of Mizoram has not been consulted.

6	Govt. of Mizoram, vide letter dated 12.11.2012, conveyed their inability to accommodate Shri Deependra Pathak, IPS in Mizoram. He was waiting for regular posting in Mizoram. A representation from Shri Deependra Pathak was
