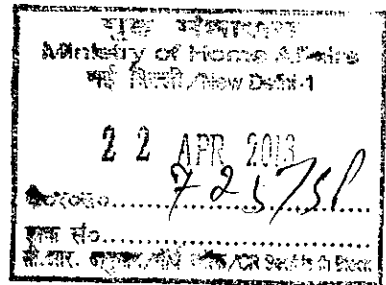

Please furnish the information as sought for below within the time limit of 30 (Thirty) days as prescribed by The R.T.I. act.


Now we want to know the following particulars as follows.

4. Whether Delhi Police alarmed Mrs Mamata Banerjee about agitation.
5. Whether Police tried to disperse agitators from main gate.
6. Who were assaulted in the incident, name please.
7. Is it a pre planned atrocities as reported to Delhi Police.
8. Whether Mamata Banerjee and others acted in accordance with instructions given by Police.
9. What is the status of gate no- 1 & 4 of Yojana Bhawan.
10. Whether Mamata Banerjee asked to take way to VIP gate to avoid agitators.
11. Whether wilfully Mrs. Banerjee taken the way thoroughfare agitators.
12. Whether Mrs. Banerjee assaulted during demonstration, if so whether she admitted any hospital at Delhi.
13. Whether Z+ security covered her during that time, if not reason.
