**ORDER**

Subject :- 1<sup>st</sup> Appeal filed by Shri Radhe Shyam under Section 19 (1) of Right to Information Act, 2005.

Whereas, Shri Radhe Shyam r/o WZ 717, Nangal Raya New Delhi-110046 has preferred his 1<sup>st</sup> Appeal dated 18.4.2013 (received in this Section on 2.5.2013) under Section 19 (1) of Right to Information Act, 2005 for not responding to his RTI application dated 11.3.2013.

2. Whereas, an RTI application dated 11.3.2013 of Shri Radhe Shyam was received in this section 20.3.2013 for providing information regarding tenure of Delhi Police officers and other question/queries. Whereas the subject matter of the RTI was closely related to Delhi Police and UTS Section MHA, it was further transferred to DCP, Delhi Police and Director (Services) MHA vide our letter No.14036/268/2013-UTP dated 4<sup>th</sup> April 2013 for providing the information.

3. Whereas, CPIO (MHA) did not have any information to share with the applicant, and he had duly transferred the RTI application to the concerned official in Delhi Police and UTS Section MHA, vide letter No.14036/268/2013-UTP dated 4<sup>th</sup> April 2013 (Copy enclosed), the action of the CPIO, is in order. Director (Services) vide letter No.14039/32/2013-UTS-I dated 22.5.2013 further transferred the aforesaid application to Delhi Police as the information sought was not available with the Director (Services) & CPIO.

4. The applicant, if so desires, may approach the PIO concerned in Delhi Police for any further information in the matter. The appeal preferred by Shri Radhe Shyam is disposed off.

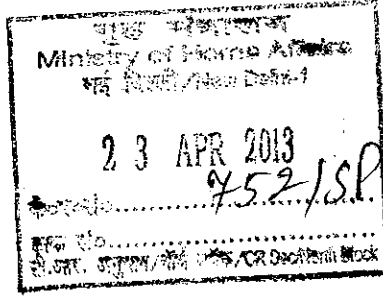
