
ORDER

Whereas, Shri Shailender Jain r/o 4378/4B, Ansari Road, Darya Ganj, New Delhi-110002 has preferred his first Appeal dated 24.4.2013 (received in this Section on 1.5.2013) under Section 19 (1) of Right to Information Act, 2005 for not providing correct reply to his RTI application dated 13.3.2013.

2. Whereas an RTI application of Shri Shailender Jain dated 13.3.2013 was received in this section on 1.4.2013 seeking information regarding 'Resident Welfare Association' and other questions/queries which are falling beyond the definition of 'information' u/s 2(f) of RTI Act 2005. Accordingly applicant was replied vide this Ministry letter No.14036/299/2013-UTP dated 18<sup>th</sup> April 2013. However, I still feel that some of the information may possibly be available with the Delhi Police.


