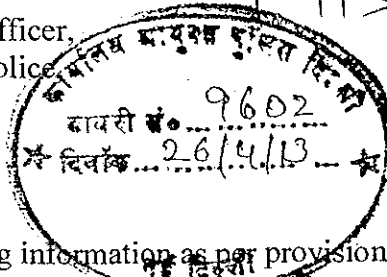

I am to state that the pictures of physical assault of Hon'ble Chief Minister to the Government of West Bengal and the Minister-in-Charge of Finance of West Bengal and other cabinet Ministers have been published in the Leading Bengali News papers of West Bengal i.e. ANANDA BAZAR PATRIKA, BARTAMAN and AI SAMOY on 10th April'2013 and the Ministers have been assaulted by the members of Student Federation of India (SFI) which are clearly appeared in the picture of the News Papers on 10th April'2013(copy enclosed).

In this connection, I hereby request you to provide me the certified copy of the information with regard to taking action against the members of SFI and the Senior Leaders of CPI (M) who are held responsible to motivate ^{abet} them.

- 1) Whether any action has been taken against the members of SFI who are held responsible for assaulting the People representatives
- 2) If yes, please provide me the list of members of SFI who are directly/indirectly involved in this assaulting
- 3) If no, please provide me the decision on the basis of which no action has been taken against them
- 4) Whether anybody of them has been arrested under Police Custody
- 5) If yes, please give me the list of them along with the no. of IPC and any other provision under which they have been arrested
- 6) Whether any FIR/complaint has been filed to the Commissioner of Delhi Police who is entrusted to look after the work of security by either any authority of the Government of West Bengal or any individual
- 7) If yes, please provide me the copy of complaints
- 8) Whether any action has been taken against the Sr. Leaders of CPI(M) who are held responsible for motivation to the members of SFI
- 9) If no, please provide me the decision on the basis of which no action has been taken against them

- 10) The name of police personnel's who were on duty to look after the work of security of the People representatives are appeared irresponsible on duty in protection of them
- 11) Whether any action has been taken against the police personnel who were found irresponsible on duty to protection of people representatives

Please provide me the aforesaid information within the mandatory period of 30 days as stipulated under Right to Information Act, 2005. If necessary, please forward the application to the concerned Department as per provision under sub-section 3 of section 6 of this act, and the requisite fee of Rs.10/- is attached herewith.
