

2) The aforementioned Applicant, humbly requests, that the Note portion of the file of the M.H.A (duly certified), alongwith Delhi Admn's letter referred under para 1 above (also duly certified), as well as a certified copy of Delhi Police, Vigilance Branch Enquiry Report, conducted against the Applicant, may please be made available to the Applicant, at the earliest, on payment of requisite charges, as stand mentioned under the R.T.I. Act, 2005, in case the same are chargeable.

5) The applicant further requests to be informed, regarding the detailed instructions, which the M.H.A follows, in respect of Weeding out of Old Records, and what measures are required to be kept on record, to ascertain at a later stage, if an R.T.I. query is received at Govt. end, for providing a certified copy of the details of files, pertaining to Vigilance / Departmental Enquiries, Old cases, as to whether the same were available or had been weeded out, and if so, is it not mandatory to keep an identifiable record, where in the particulars of the files, which had been weeded out, are recorded, along with the particulars of the Competent Authority, under whose ~~order~~ dated orders, the same were weeded out.

6) The requisite fee of Rs10/-, in the form of two Postal Orders of the face value of Rs5/- each, bearing NOS(1) 59C 0083904(2) 66C 024455 issued in favour of \_\_\_\_\_ are enclosed, as per the instructions spelt out under The R.T.I. Act - 2005.
