Tenders sent by any other mode will not be considered and the same will be rejected summarily. All the documents in support of eligibility criteria etc., are also required to be scanned and uploaded along with the Tender document latest by **31.03.2021 at 11:00 AM**. No tender document will be accepted after the expiry of stipulated date and time for the purpose under any circumstances what so ever.

3. The bidder may submit an **Earnest Money of Rs. 5,000/- (Rs. Five Thousand only)** by way of **Demand Draft** in favour of "DDO, Ministry of Home Affairs, New Delhi-110001" to the **Under Secretary (Ad.III), Hall No. 2, Ministry of Home Affairs, North Block, New Delhi** latest by **31.03.2021 at 10:00 AM**.

4. The vehicles are available for inspection from 11.00 AM to 3.00 PM on all **working days** w.e.f. 11.03.2021 to 30.03.2021.

5. The e-Bid received in time will be opened at **03:00 PM on 31.03.2021** in Room No.2, North Block, New Delhi – 110001. The Bidders or their representative (not more than one) may be present, if they so desire at the time of opening of e-Bids.

6. All entries should be legible and filled clearly, if the space provided for furnishing information is insufficient; a separate sheet duly signed by the authorized signatory may be scanned and uploaded. No correction in the Bid is permitted.

7. No bidding firm/person will be allowed to withdraw its bid after opening of bids.

8. The auction will be governed by the following conditions: -
- i) The successful bidder will be required to deposit the **balance bid amount after deducting earnest money of Rs. 5,000/- (Rs. Five Thousand only)** within one week of intimation about successful bidder by way of Demand Draft drawn in favour of **“DDO, Ministry of Home Affairs, New Delhi - 110001”**
 - ii) The delivery of the sold vehicle will be given only to the successful H-1 bidder after submission of documentary evidence in support of residential status (Ration Card / Voter Identity Card / Aadhar Card) in case of individual and Registration Certificate in case of firms etc.
 - iii) The sold vehicle shall have to be removed by the successful bidder immediately at his own expenses from the office premises.
 - iv) The vehicle will be disposed of on “as is where is basis” and no guarantee for its worthiness or quality will be given by this Ministry.
 - v) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously.
