Tenders sent by any other mode will not be considered and the same will be rejected summarily. All the documents in support of eligibility criteria etc. are also required to be scanned and uploaded along with the Tender documents. No tender documents will be accepted after the expiry of stipulated date and time for the purpose under any circumstances what so ever.

The **Earnest money Deposit** (EMD) of **Rs.50,000/-** (Rupees Fifty Thousand only) in the form of Demand Draft/Pay Order/Bankers cheque drawn in favour of **Drawing & Dispersing Officer (Cash)**, Ministry of Home Affairs, New Delhi has to be submitted to the Section Officer (Ad.III), MHA, New Delhi, Hall No. 2 (Jalebi Chowk), North Block, New Delhi by **10:00 A.M.** till **18/06/2018**. The Earnest Money will be refunded to the un-successful tenderer's/bidder's after finalization of the contract.
