The Bidders may drop their Earnest Money of Rs.25,000/- by way of Demand Draft drawn in favour of "DDO, Ministry of Home Affairs, North Block, New Delhi - 110001" in the Tender Box of this Ministry in Hall No.2, Jalebi Chowk, North Block, New Delhi latest by 8<sup>th</sup> October 2018 at 2.00 P.M.



- i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs.25,000/- within one week of intimation of successful bidder by way of Demand Draft drawn in favour of "DDO, Ministry of Home Affairs, North Block, New Delhi - 110001"
- ii) The delivery of the sold vehicle will be given only to the successful H-1 bidder after submission of documentary evidence in support of residential status (Ration Card / Voter Identity Card / Aadhar Card) in case of individual and Registration Certificate in case of firms etc.
