Open Tender Enquiry (OTE) No. D/21013/3273/20.08.2018/P-1 dated 19.12.2018 floated on CPP Portal and opened on 27.02.2019 (Tech bid) for Supply, Installation and Commissioning of Hardware and Software Training Infrastructure for APCO Phase-II Radio Trunking System at CPRTI, New Delhi.

A OTE dated 19.12.2018 was floated on CPP portal and was opened on 27.02.2019 (Technical bid). The following two firms participated in tender details as under :-

- 2. Tender Evaluation Committee (TEC) under the Chairmanship of Addl. Director, DCPW, carried out technical evaluation of technical bids of offers given by the above 02 firms against subject store mentioned in the said tender enquiry. The TEC thoroughly examined the qualification criteria, eligibility criteria and evaluated the techno-commercial and technical parameters of all the above bids. The TEC in its report mentioned few short comings/observations in the Technical Bid submitted by the M/s Syrma Technology Pvt. Ltd.,:-
 - (i) As per Qualification Criteria-Clause 5(c) of Annexure II at page 9 of OTE related to completion of the similar nature (Radio Trunking System) projects, two similar nature projects were **not found** in the name of M/s Syrma Technology Pvt. Ltd in past 07 years.
 - (ii) As per Clause No. III(p) of Section I at page No.32 of OTE, the equipment(s) deployed should support IPv4 and IPv6 and bidder has submitted that the offered system/equipment(s) do not support IPv6.
 - (iii) As per Clause No. 5.3 (1.14) & 5.4 (1.13) of Section I, at Page No.36 & 38 respectively of OTE regarding IOP Certification, the bidder **has not submitted** documents related to IOP Certification for APCO Phase-II System.
 - (iv) As mentioned in Clause No. 5.3 (1.15) of Section I at Page No.36 of OTE (Changed as per corrigendum No.2 dated 24.01.2019, S.No.14) related to Encryption, the bidder has submitted – "Not Complied".

- (v) As per point No.21 of Appendix-2 at page No.43 of OTE regarding valid Dealer Possession License (DPL) from WPC, the submitted DPL was dated 27.03.2019, whereas the last date of bid submission was 27.02.2019. Hence, the bidder did not have required DPL Certificate at the time of submission of bid.
- (vi) The bidder **has not submitted** compliance against Schedule of Requirement, mentioned at Section-II, Page No.40, of OTE, including corrigendum No.2 dated 24.01.2019.
- (vii) The bidder is offering equipments with deviations (in Clause 5 of Appendix-2, Clause 10(a) of Appendix 4 & Appendix 12) in respect of technical particulars and specifications/drawings specified in the schedules to tender, which are not acceptable.

Hence, Bidder is ineligible.

3. Based on the observation/short coming noticed TEC recommended the following in its report:-
