Terms and conditions of the contract shall be as under:-

- The work includes comprehensive contract for repairing/maintenance of 1. Window Air Conditioners and Split Air Conditioners as well as shifting, Gas charging, repair/maintenance and re-installation, dismantling, provision of Indoor/outdoor Fan Motor and Running Capister etc.
- During the contract period the contractor will have to depute 2. their experienced Engineers/Air-Conditoner Mechanics on all working days between 9.00 A.M. to 5.30 P.M. at MHA premises located at North Block, New Delhi, NDCC-II Bldg., Jai Singh Road, New Delhi, Major Dhyan Chand National Stadium, India Gate, New Delhi and Jaishalmer House, New Delhi to attend day to day complaints. The contractor will also have to depute their Engineers/AC Mechanics on holidays and also at odd hours, if the situation so demands. The Engineers/AC Mechanics of the firm will be required to visit this Ministry's offices located at North Block, NDCC-II building, Jai Singh Road, Major Dhyan Chand National Stadium, Jaisalmer House, Lok Nayak Bhawan, Sardar Patel Bhawan, Vigyan Bhawan Annexe and at the residential offices of the Ministers, every day to attend the complaints, if any, for which no extra payments will be made to the firm.
- Period of Contract initially would be for one year from 01-04-2019 to 3. 31-03-2020. However, the contract would be further extended for maximum two years on the basis of satisfactory service provided by the firm during the above mentioned period. The contract can be terminated by this Ministry at any time without assigning any reason if the work is found unsatisfactory. In that case, the work may be entrusted to any other firm at the risk and expense of the contractor. In this connection, the decision of this Ministry shall be final and binding on the contractor/firm.
- Initial servicing of the Air Conditioners (Window and Split) will have to be 4. completed within 15 days of the commencement of the contract. The contractor will maintain all Air Conditioners of this Ministry in good working The total number of Air-conditioners are approximately 250 condition. (55-Window ACs and 195-Split ACs). Payment regarding maintenance of all type of Air-conditioners will be made on actual work done on monthly basis. No advance payment will be made to the firm.
- A certificate along with stamp from the occupants of the room/concerned 5. officer towards satisfactory completion of the work will be obtained by the firm and submitted along with bills. The contractor has to use all products/ materials of branded ISI mark only. During the period of contract no request for increase in the rates will be entertained. The rates as quoted will be valid during the contract period.
- The Contract will be awarded to the firm for the comprehensive of Air-conditioners (Window and Split ACs) as 6. repair/maintenance mentioned at Annexure on the basis of total overall rates (The unrealistic rates quoted by the firm may not be accepted for any of items).

- 8. The tenders received without earnest money will not be considered. The earnest money will be returned in respect of the unsuccessful bidders after finalization of tender process. No interest will be paid on this earnest money.
- 9. The successful bidder will have to deposit Rs.1,50,000/- (Rupees one lakh fifty thousand only) in the form of FDR in favour of DDO (Cash), MHA, New Delhi as Performance Security Deposit to be valid up-to 30.06.2020.
- 10. The contractor shall not employ any person who has not completed the eighteen years of age. The contractor shall be responsible for payment of wages/settlement of dues of workers engaged by the firm as per prevailing labour wage laws in force in NCT of Delhi and this Ministry shall not be a party to any dispute between the contractor and workers. There would be no relationship between this Ministry and labour so engaged by virtue of this contract.
- 11. The damage caused, if any, either to any electric item or to any other property of the Government through negligence or otherwise, shall be at the risk, cost and responsibility of the contractor. The financial or any other loss suffered by the Government on this account shall be made good by the contractor and decision of the Head of Department in this context shall be binding on the contractor.
- 12. At present, the contractor should have been providing services at least two Government Departments, their monthly billing should be more than Rs.25,000/- per month. The firm has also to submit the performance certificate at-least from two Ministry's/Government Departments.
- 13. The firm should have a valid registration certificate of Service Tax/GST and annual turnover more than Rs.15,00,000/- per annum. Copies for the last three years be uploaded with Technical Bid.
- 14. The firm should not have been black listed by any Ministry/Department of the Government of India. The tendering firm/bidders shall have to give a certificate stating that they have not been blacklisted & banned with the Government Ministries/Departments.
