OFFICE MEMORANDUM

Sub: Global Tender Enquiry (GTE) No. D/21013/3274/27.09.2018/P-1 dated 17.12.2018 floated on CPP Portal and opened on 22.01.2019 (Tech bid) for (i) UV-Visible Spectrophotometer-Qty. 06 Nos (ii) Gas Chramatography-Mass Spectrometry (GC-MS) System-Qty. 06 Nos and (iii) Gas Chramatography System(GC) – Qty 06 of each item for CFSL - Bhopal, Chandigarh, Guwahati, Hyderabad, Kolkata and Pune of DFSS.

A GTE dated 17.12.2018 was floated on CPP portal and was opened on 22.01.2019 (Technical bid). The following four firms was participated in tender details as under:-

2. Tender Evaluation Committee (TEC) under the Chairmanship of Director, CFSL Hyderabad, carried out technical evaluation of technical bids of offers given by the above 04 firms against subject items mentioned in the said tender enquiry. The TEC thoroughly examined the qualification criteria, eligibility criteria and evaluated the techno-commercial and technical parameters of all the above bids. The TEC in its report mentioned few short comings/observations in the Technical Bid submitted by the following firms:-

(A) M/s R- Initiative Enterprises for UV-Visible Spectrophotometer

(i) Qualification Criteria as per clause 5(ii) of GTE of Annexure II.

"The Tenderer should have average Annual turnover of **Rs. 4 Crores** during the last 3 years i.e. 2015-16, 2016-17, & 2017-18 to meet the obligation under contract. They should submit audited balance sheet and profit and loss account of last 03 years, duly authenticated by a Chartered Accountant/ Cost Accountant in India and bank's report for their credit worthiness".

 Annual Average turnover is Rs. 2.72 Crore for the years 2015-16, 2016-17 and 2017-18 as stated by the firm in Appendix -3 and in the Audited Balance Sheet submitted by the firm in the Bid.

(ii) Annexure II Clause 5 (v) at page 13 of GTE.

"The bidder should have service support center in India to offer application training for Forensic Analysis with field application / service support to help solve chemistry and instrumentation problems".

• The Bidder has not submitted the desired document i.e. the list of the service support centers.

(iii) Annexure II Clause 6.2 (Evaluation Criteria) at page 14 of GTE

In response to the letter no. D/21013/3274/27.09.2018/P-4 dated: 08.02.2019 the firm has not submitted technical bid for the evaluation of the subject store.
 Hence, Bidder M/s R- Initiative Enterprises is un-responsive and is in eligible.

(B) M/s Analytical Technologies limited

(I) FOR GAS CHROMATOGRAPHY SYSTEM:

(i) Annexure II Clause 5 (i) at page 12 of GTE

"Tenderer should have supplied and installed successfully at least 1 equipment in the last 5 years before the date of opening of tender and functioning satisfactorily, without adverse report. Report from the institution to whom it has been supplied about satisfactory performance must be enclosed with technical bid".

The Bidder has failed to produce necessary satisfactory report from the institution to which it has supplied the equipment within the stipulated time.

Hence, Bidder is non-responsive.

(II) FOR UV-Visible Spectrophotometer

(ii) Appendix- 2 of GTE

"Resolution – 0.2 nm or better" and "Stray light – At 198 nm (for KCI) 0.5% T or better, At 220 nm NAI(ASTM method) 0.0001% T or better, At 340 nm (for NaNO₂) 0.0001 % T or better."

- Discrepancy in resolution mentioned in Technical Bid and product literature i.e.
 0.02nm and 0.00 nm, respectively
 - Ambiguity noted in product brochure available on official website (www.analyticalgroup.net) of the firm and brochure attached with the bid under the parameters "Web length Resolution" and "Stray Light" (Screenshot Copies enclosed). The documents in the bid submitted by bidder are not reliable.

Hence, Bidder is in-eligible.

3. Based on the observation/short coming noticed TEC recommended the following in its report :-
