The quotation should be in a sealed cover superscribed as "**Quotation for disposal of 34 condemned vehicles**" along with the bid security money of **Rs.95,000/- (Rupees Ninety five thousand only)** in the form of Bank/Demand draft payable to **DDO/M, IB, New Delhi** drawn on any scheduled Bank located in New Delhi. The quotation should be for all 34 vehicles and rate should be quoted vehicle wise. 5. The condemned vehicles will be sold to the highest bidder. However, the competent authority reserves the right to reject any or all quotations without assigning any reason thereof.
6. The successful bidder will have to make full payment by **31.8.2017 (17:00 hrs.)** and only then he would be allowed to remove the items from the premises. The successful bidder has to lift the vehicles completely at his own cost and clear the site completely within two days from the date of deposit of full payment, failing which the bid security money shall be forfeited and pecuniary loss, if any, shall be recovered from him. The bid security money of successful bidder shall be returned after cleaning the site completely including the removal of scrap etc.
7. The bid security money of unsuccessful bidders shall be returned after the process is over.
