That the appellant aggrieved with the non-information provided by CPIO/Respondents as information sought as per RTI application dated 04/10/2013. The appellant, therefore is filing the present appeal amongst the following grounds: A. Because the CPIO seems to be over smart being a beaurocrate, 1AS officer and he think other common people are fool in this bloody country, as howsoever he runs this country are well known and he reply whatever he wants and the information seeker will keep quit. Either you reply or say that you don want to reply. So that I could make application before President Barrak obama

or Rakhi sawant as per CPID reply for information which CPIO did not provide working as IAS officer who are known for raping the law as per his own convenience. B. Because CPID deliberately did not provided any information for the point No. 1 to 3 of RTI application dated 04/10/2013, which is exclusively related to the Ministry of Home affairs and non others. Therefore,

D.Because the respondent has violated the principle of natural justice by giving
such reply dated 04/10/2013 without any efforts to collect the information from his
departments and which is gross negligence on his part of discharging his duty.
