Applications are invited in the prescribed proforma (Annexure-A, copy enclosed) from eligible candidates to fill up 01(one) post of Judge Attorney General (Deputy Inspector General) Group 'A' Gazetted in Sashastra Seema Bal by Deputation/absorption or re-employment basis in Level-13A of pay Matrix (Rs.131100-216600) as per 7<sup>th</sup> CPC, as per eligibility criteria given below:-

**Eligibility criteria**

Officers of the Central Government or State Government or Union territories or Central Armed Police Forces including Sashastra Seema Bal, having a degree in law from a recognised University or equivalent;

(i) holding analogous post in the Level 13A in the pay matrix (Rs. 131100-216600/-) or equivalent on regular basis in the parent cadre or department, having fifteen years of experience in dealing with legal matters or court cases; or

(ii) an officer who is a member of the State Judicial Service holding analogous post in the Level 13A in the pay matrix (Rs. 131100-216600/-) or equivalent having fifteen years of experience in dealing with legal matters or court case; or

(iii) with two years regular service in the grade of Commandant or equivalent in the Level-13 in the pay matrix (Rs. 123100-215900/-) or equivalent, with fifteen years of experience in dealing with legal matters or court cases.

Note 1: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same Organisation or Department shall ordinarily not exceed three years.

Note 3: The upper age limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of receipt of application.

**For Ex-servicemen deputation/re-employment.**

The Armed Forces Officers in the rank of Brigadier or equivalent in the department of Judge Advocate General in Army/Navy/Air Force, due to retire or who are to be transferred to reserve within a period of one year, shall also be considered. Such officers shall be given deputation terms up to the date on which they are due for release or superannuation from the Armed Forces; thereafter they may continue on re-employment. (Re-employment up to the age of superannuation with reference to the post in the organisation.)


