Please refer to your online RTI application MHOME/R/2014/61309 dated 30th May, 2014 submitted under the RTI Act, 2005 (received in this section on 04.06.14).

2. It is to inform you that, Section 49 of the DM Act, 2005 (53 of 2005), envisages that every Ministries or Department of the Government of India shall make provision, in its annual budget, for funds for the purposes of carrying out the activities and programmes set out in its disaster management plan. Since Disaster Management is a multi-disciplinary subject, requiring coordinated and holistic approach from all Ministries/Departments of Central and State levels, the Ministry of Home Affairs does not centrally maintain details of fund allocation made by different Ministries as stipulated u/s 49. However, the Planning Commission and Department of Expenditure may have some information in the matter.

3. If you are not satisfied with this reply, you ^may prefer an appeal under Section 19 (1) of the RTI Act, 2005 within thirty days from its receipt to
