

However, it is informed that UTS-II Section deals with DANICS which is also a part of UTCS. Information regarding DANICS, the details of participating UTs, list of feeder services to DANICS etc. may be assessed from the website of the Ministry ([www.mha.nic.in](http://www.mha.nic.in)). Point No. 3 of the application is not clear. There is no such check list as mentioned by the applicant. Information regarding point No. 4 can be had from A & N Administration after giving them relevant details of the proposal, if any. The applicant has not mentioned the date of the proposal and other relevant details. Therefore, the Ministry is not in a position to ascertain as to whether any proposal has been received or not.
