With reference to his applications dated 14.08.2014, copies of which have been received in the UTS-II Section/MHA on 20.08.2014 and 21.08.2014, Shri Yashpal Garg informed that the RTI applications have been analyzed and the point-wise reply to the information sought by him is as under:

Point No. 01 & 02: The applicant is informed that the copies of the last orders vide which the DANICS & DANIPS officers were inducted to IAS and IPS respectively are enclosed. The applicant is informed that Shri R.K. Mishra, who had joined DANICS on 28.04.1986 is figuring last in the list of DANICS officers inducted to IAS. Further, Shri P.K. Mishra, who had joined DANIPS on 02.04.1994 is figuring last in the list of DANIPS officers inducted to IPS.

Point No. 03 to 06:- As per the records, a proposal for introduction of the pay scale of Rs. 18,400-22,400/- in DANICS was mooted in the year 2006. After getting the approval of the then Home Minister, a calinet note was sent to Cabinet Secretariat. However, subsequently the matter was closed in consultation with DOP&T. The undersigned submitted a representation dated 17.01.2014 requesting grant of higher pay scale due to stagnation in DANICS because of delay in induction into IAS. The representation was forwarded by the Services Department, Govt of NCT of Delhi vide letter no. 30/124/93/S-I/309 dated 28.01.2014 to the Ministry of Home Affairs, Govt of India (Copy enclosed). The matter is still pending. It is requested that the following information may kindly be provided under the RTI Act so that the matter may be taken-up at appropriate forum:

1. The third proviso to the section 5(2) of the IAS (Appointment by Promotion) Regulations, 1955 prescribes not less than 08 years of continuous services for substantive member of State Civil Service for his promotion to IAS.

Please inform, generally after how many years of service, as per the last order of promotion, DANICS officers got promoted into

IAS?

Officers of which batch were lastly got promoted into IAS and IPS from DANICS and DANIPS respectively?

It has been gathered that few years back, in view of the acute stagnation, the Ministry of Home Affairs moved a proposal to Tiolally grant pre-revised scale of Rs. 18,400-22,400/- (i.e. grade pay of R 10,000/-) to DANICS. What is the present status of the proposal? grant pre-revised scale of Rs. 18,400- 22,400/- (i.e. grade pay of Rs.

4. Whether the then Hon'ble Home Minister, Govt of India had desired/approved placing a agenda before the Union Cabinet on the issue of grant of pre-revised scale of Rs. 18,400- 22,400/- (i.e. grade pay of Rs. 10,000/-) to DANICS?
