

# OUTCOME OF THE SCREENING PROCESS FOR APPOINTMENT ON COMPASSIONATE GROUNDS IN SSF/RECEPTION ORGANIZATION, MHA.

This is regarding filling up of 24 vacancies in SSF/Reception Organization, MHA under compassionate appointment quota. All the cases in which the date of death (DoD) of the Government employee was prior to 01.04.2020, have been considered (at least once) in the SSF/RO, MHA. Therefore, it was decided with the approval of the Competent Authority, to consider only the cases in which the date of death of the Government employee is between 01.04.2020 to 31.12.2023 in the present screening process.

- 2. Total 16 application have been received and they were objectively assessed as per the relevant guidelines of DoP&T, and the point-based merit scheme (100 points) adopted by Ministry of Home Affairs which takes into consideration parameters like family pension, terminal benefits, left over service, annual income, movable/immovable property, number of dependents of the deceased Government employee etc.
- 3. It is informed that objections, if any, may be brought to notice by the concerned candidates within 15 days of uploading of the information on MHA's website.
- 4. Accordingly, Marks of the candidates/relevant remarks at this stage may be seen at **Annexure A**.

The above details are placed on the website of Ministry of Home Affairs, in accordance with the provisions contained DoPTs OM No. 43019/92019-Estt.(D) dated 23.08.2021.

### एसएसएफ/स्वागत संगठन, गृह मंत्रालय में अनुकंपा आधार पर नियुक्ति के लिए स्क्रीनिंग प्रक्रिया का परिणाम।

यह अनुकंपा नियुक्ति कोटा के तहत एसएसएफ/स्वागत संगठन, गृह मंत्रालय में 24 रिक्तियों को भरने के संबंध में है। जिन मामलों में सरकारी कर्मचारी की मृत्यु की तिथि 01.04.2020 से पहले थी, उन पर एसएसएफ/आरओ, गृह मंत्रालय में (कम से कम एक बार) विचार किया गया है। अत:, सक्षम प्राधिकारी के अनुमोदन से वर्तमान स्क्रीनिंग प्रक्रिया में केवल उन मामलों पर विचार करने का निर्णय लिया गया जिनमें सरकारी कर्मचारी की मृत्यु की तारीख 01.04.2020 से लेकर 31.12.2023 के बीच है।

- 2. कुल 16 आवेदन प्राप्त हुए हैं और उनका मूल्यांकन निष्पक्ष रूप से कार्मिक एवं प्रशिक्षण विभाग के संबंधित दिशानिर्देशों और गृह मंत्रालय द्वारा अपनाई गई बिंदु-आधारित मेरिट योजना (100 अंक) के अनुसार किया गया, जिनके लिए पारिवारिक पेंशन, सेवांत लाभ, बची हुई सेवा अवधि, वार्षिक आय, चल/अचल संपत्ति, दिवंगत सरकारी कर्मचारी के आश्रितों की संख्या आदि जैसे मापदंडों को ध्यान में रखा गया है।
- 3. यह सूचित किया जाता है कि गृह मंत्रालय की वेबसाइट पर सूचना अपलोड करने के 15 दिनों के भीतर संबंधित उम्मीदवारों द्वारा आपत्तियों, यदि कोई हो, को ध्यानार्थ लाया जा सकता है।
- 4. तदनुसार, इस स्तर पर उम्मीदवारों के अंकों/प्रासंगिक टिप्पणियों को अनुबंध क में देखा जा सकता है।
