


Subject: Application filed by Shri Gaurav Deshal under the Right to Information Act, 2005 – transfer thereof.



निवेदन यह है कि प्रार्थी ने SSC Recruitment of Constable (G.D) in CAPFs and Riflemen in Assam Rifle 2012 की परीक्षा जो 12 May 2013 को सम्पन्न हुई जिसे प्रार्थी ने जिसका अनुक्रमांक 2002028831 है 77 अंकों से उत्तीर्ण किया। जिसका स्वास्थ्य परीक्षण 21/1/2014 को कराया गया जिसमें प्रार्थी को आँखों के संदर्भ में पुनः स्वास्थ्य परीक्षण दिया गया। पुनः स्वास्थ्य परीक्षण 19/3/2014 को कराया गया जिसमें चिकित्सा अधिकारी द्वारा प्रार्थी को स्वस्थ प्रमाणित किया गया परन्तु अंतिम चयन सूची जिसमें CRPF की नक्सल क्षेत्र की 69 अंकों पर तथा SSF की नक्सल क्षेत्र की 75 अंकों पर व ITBP की नक्सल क्षेत्र की 72 अंकों पर और Assam Rifle की 69 अंकों पर लगने के बावजूद प्रार्थी का चयन अंतिम चयन सूची में नहीं हुआ।
