- 2. <u>Description</u>. Wet lease of one twin engine Helicopters (6 to 7 seats) for Ministry of Home Affairs for an initial period of two years, extendable for further period on the same terms and conditions. The helicopter will be utilized mainly for official use of VIPs and senior officers of Govt. of India in North Eastern States of India. The helicopter would have to be stationed at Guwahati, Assam.
- 3. <u>Delivery period</u>. Bidder to mobilize the helicopter at the identified base within 15 days from the date of letter of intent. The expected utilization is around approx 400 hrs. per annum. Obtaining airbase approval will be responsibility of the operator.
- 4. Bidders whose Technical Bids are found unqualified, their Price (Financial) Bids shall not be opened.
