NOTIFICATION

S.O. 1523 In pursuance of clause (1) of article 239 of the Constitution, the President hereby directs that the Administrators (whether known as Lieutenant Governor, Chief Commissioner or Administrator) of the Union Territories of Delhi, Manipur, Tripura, the Andaman and Nicobar Islands, the Laccadive Minicoy and Amindivi Islands, Dadra and Nagar Haveli, Goa, Daman and Diu, Pondicherry and Chandigarh, shall, subject to the control of the President and until further orders, exercise the powers and discharge the functions of the State Government under the Contract Labour (Regulation and Abolition) Act, 1970, (37 of 1970) within their respective Union Territories.



का० आ० 1813 संविधान के अनुच्छेद 239 के खण्ड (1) के अनुसरण में, राष्ट्रपति एतद्वारा निदेश देते हैं कि दिल्ली, मणिपुर, त्रिपुरा, अंडमान और निकोबार द्वीपसमूह, लक्षद्वीप, मिनिक्वोय और अमोनदोवी द्वीपसमूह, दादर और नागर हवेली, गोवा, दमण और दीव, पाण्डिचेरि और चंडीगढ़ संघ राज्यक्षेत्रों के प्रशासक (चाहे वे उपराज्यपाल, मुख्यआयुक्त या प्रशासक कहलाते हों) राष्ट्रपति के नियंत्रणधीन और आगे आदेश होने तक अपने-अपने संघ राज्यक्षेत्रों के भीतर संविद् श्रमिक (विनियमन और उत्सादन) अधिनियम, 1970 (1970 का 37) के अधीन राज्य सरकार को शक्तियों का प्रयोग और कृत्यों का पालन करेंगे।
