NOTIFICATION

S.O. 244.- In pursuance of clause (1) of article 239 of the Constitution, the President hereby directs that the Administrator of every Union territory (whether known as Administrator, Chief Commissioner or Lieutenant Governor) shall, subject to the control of the President and until further orders, also exercise the powers and discharge the functions of the State Government under section 6 of the Criminal and Election Laws Amendment Act, 1969 (35 of 1969) within that Union territory.
