ORDER

Delhi, the 18th May, 1949

No. F.1(71)/49-Electricity.—In exercise of the powers conferred by Section 3 of the Bombay Electricity (Emergency Powers) Act 1946 as extended to the Province of Delhi and whereas this measure is considered essential to regulate the consumption of electricity supply in Delhi, the Chief Commissioner of Delhi is pleased to direct that electric power consumers supplied by the Delhi Central Electric Power Authority Ltd., the New Delhi Municipal Committee and the Garrison Engineer, Delhi Division, Delhi Cantonment (hereinafter called the "Licensees") shall not use electricity for operating any industrial machinery or plant for the purposes of industry or manufacture of goods of any description or workshop during the day of the week as specified in the Schedule appended to this Order.

2. The Chief Commissioner of Delhi is further pleased to authorise the Licensees in exercise of the powers conferred by sub-section (1) of section 4 of the Act to discontinue the supply of electricity to any consumer who contravenes any direction made in this Order provided that:

The Licensee shall:

- (i) before discontinuing the supply give the consumer not less than 48 hours notice in writing of his intention to do so,
- (ii) on discontinuing the supply, communicate to the Chief Commissioner of Delhi within twenty-four hours from the time of discontinuance the circumstances in which he has done so,
- (iii) on being directed by the Chief Commissioner recommence the supply with all possible speed.

3. A copy of this Order shall be published in the Official Gazette and by public advertisement in the Press and the Order thus notified shall be deemed to have been served on the categories of firms and undertakings as specified in the Schedule appended to this Order.

SCHEDULE

The supply of electricity is prohibited to the following on the *day of each week* as indicated below:—

SUNDAY

1. Reinforced Cement Concrete Pipe Factories.
2. Metal Rolling Mills.

3. Electroplating.
4. Stone Crushers.
5. Pottery Works.
6. All industries not specified in this Order.

MONDAY

1. All flour, dal, oil and rice mills west of Qutab Road and Rajpur Road, including all mills in Civil Lines and Azadpur and the five mills noted below :-

" 28008 ~~Bela~~ Road
" 24340 Bela Road
" 24661 Naya Bazar
" 26449 Chowri Bazar

TUESDAY

1. Printing Presses excluding Daily Newspaper Printing Presses.
2. Saw Mills and Wood Work.

WEDNESDAY

1. Machine Shops including all repair workshops situated in the area of the D.E.S.T. Division.
2. Flour Mills in the New Delhi Municipal Committee's area.

THURSDAY

1. All flour mills other than those to whom the supply is prohibited on Mondays and Wednesdays.

FRIDAY

1. Dehydrating.
2. Chemicals.
3. Dye.
4. Wire making.
5. Enamel Works.
6. Rubber.
7. Spray painting.
8. Foundries.
9. Welding.
10. Brass polishing.
11. Battery charging excluding battery charging by the P & T Department.
12. All machine shops including repair workshops situated in the New Delhi and Cantonment areas.

SATURDAY

1. Chaff cutting.
2. Textiles.

EXCEPTIONS

This Order will not apply to the following industries :-

- (1) Ice Factories and cold storage.
- (2) Water pumping.
- (3) Sewage disposal pumps.
- (4) Daily News Printing Presses.
