
I am directed to refer to your application dated 4.7.2014, on the subject cited above, received in UTS-I Section on 2.9.2014.



Kindly take cognizance of this application for information under the RTI Act, 2005 for the information to be provided on the issues herein mentioned.

As per the ruling of the Hon'ble Supreme Court in the matter of *Prakash Singh v. Union of India*, and the guidelines enunciated, there was a requirement for the states to set up State Security Commissions apart from the other directives.

I request you to kindly furnish information related to state of Uttar Pradesh, Delhi, Orissa, West Bengal, Haryana and Punjab on following questions:

I. Has the state constituted the State Security Commission, for the transparent and unhindered working of the Police without any Governmental interference?

1. If there was any such commission set up then when was it setup?
2. Who are the commission's members and what post they are holding?
3. Has the commission if it is set up, made any recommendations?
4. How many meetings of the commission has been held till date?
5. Kindly provide the minutes of the all the meetings held till date.

II. Has there been a Police Establishment Board constituted?

1. If yes, when was it formed?
2. What are the powers of the board?
3. Who are the members of the Police Establishment Board and what are their positions they are holding?
4. Any recommendations that have ever been given by the Police Establishment Board, kindly provide information of all the recommendations made.
5. Kindly provide the minutes of the meetings of the Board till date.

III. Has the state established a Police Complaints Authority at the State level to look into complaints against police officers of the rank of Superintendent of Police and above?

  - b. Please provide any documents and records relating to complaints received by the Police Complaint Authorities and any response or action by the Authorities.
  - c. Please provide any minutes of meetings conducted by the Police Complaint Authorities.


